"How come Atty Argel is different from others in the job?" queried a couple who has been bored waiting while under the services of another migration agent and seriously contemplating to avail of Atty.Argel's services upon learning her skills from those who got their permanency quicker.

She studied at St Theresa's College in Manila and graduated at the University of the Philippines, College of Law in 1970. She has two brothers, Pacifico, a retired manager of a rural bank, and Manuel, Jr., who was appointed in 1995 as Judge in the Regional Trial Court in Laoag City; and a sister, Rosario Thurston, who has been a computer professor in Australia since 1982. Her father, Manuel, Sr, a Bachelor of Laws graduate at Georgetown University in Washington DC, used to be a Regional Trial Court Judge in Caloocan City. Her mom, a member of the famous clan in Lahoz, was also a lawyer.

"How and when did you migrate to

"I came to Australia as a permanent resident immigrant in 1988. Before immigrating to Australia, I had my own law practice in Metro Manila, which was why I could hardly get a job in Sydney when I arrived. They always say I am over-qualified. They saw in my resume that I was one of the highest-paid corporate lawyers in the Philippines. I worked in the biggest law firm in the world, Baker & and McKenzie, in 1999, which became worldwide in 1988. As I couldn't get a job, my friends in the diplomatic group advised me to put up my own migration practice office, which was what I did and the rest is his-

tory. It worked wonders which put me where I am today."

Among her many most significant achievements is the recognition bestowed by the Philippine Regulatory Commission (PRC) Licensure Board Examinations in the assessment of qualifications under NOOSR's the Philippine Country Education Profile (CEP). Through her representations in the Federal Parliament, a PRC Board Passer is now recognized as a holder of Australian Bachelor degree. She is the author of Time-Saving Immigration Practice Solutions (TIPS) on General Skilled Migration (GSM) visas, published online.

Atty. Argel was the first recipient of the Filipino Australian Women's Achievement Award (FAWAA) for corporate practice/entrepreneurship in New South Wales. She received the award in 2006. In 2008, she was awarded the first "Outstanding Alumni Achievement Award for Law" and for the "Community Service" by the University of the Philippines Alumni Association of Australia in New South Wales.

She continues to push beyond the boundaries of what is possible and obtains exemplary results in the service of Filipinos worldwide.

"What about the challenges you have encountered as lawyer and migration agent in Australia?"

"A lot them, "she said. "For example, when a client does not appear to be able to meet criteria for visa grant, I always find a way by obtaining more information during the interview with the client. Through skill I always find evidence to meet the criteria. I concentrate on the merits of the case rather than the collection of money. I get 90 percent rate of success and the 10 percent is because the client doesn't me the whole truth. I don't accept the money

unless they have a chance for success a don't collect money that I don't deserv get. I thank God for my clean science. I know God points a finger at - you are accountable for what you when you don't do what is right, so better to do right all the time and a clean with the word accountability."

Now on her 16th- year of migra practice, Imelda holds an impeco tract record which only one partner application ever refused but still pen at the Migration Review Tribunal.
