Are you an overseas qualified accountant applying for skills assessment?

The three Authorising authorised assessing bodies for accountants are CPA Australia (CPAA), Institute of Chartered Accountants in Australia (ICAA) and National Institute of Accountants. You only need to apply to one of them.

Do you need to pass the CPA Board Examinations in order to obtain a suitable skills assessment? **NO**!

You do not have to be a Certified Public Accountant (CPA) in your country of origin to qualify for a suitable skills assessment as an Accountant. Moreover neither English test nor work experience is required as a part of your skills assessment.

The overseas registration as a CPA is normally required only if you apply under the Association *Membership Pathway* with ICAA. The *Qualifications Pathway* which is more common pathway is the where assessments are based on educational qualifications and completion of minimum core subjects in the degree curriculum.

Under this pathway, the basic requirement for successful skills assessment is that your educational qualification is comparable to an <u>Australian Bachelor degree</u>. The three bodies refer to the Country Educational Profile (CEP) of the country of your education to compare your overseas qualifications with qualifications under the Australian Qualifications Framework (AQF). The advantage of passing the CPA Board exams if you obtained your Bachelors degree in Accounting in the Philippines is that your degree is comparable to an Australian Bachelor degree. However, the CEP relates only to the educational level of the qualification, not the field of study of Accounting. Thus, in addition to the above, you must have completed 9 of the 12 core study areas.

In other words, if you have an overseas qualification comparable to an Australian Bachelor degree based on the Country Educational Profile (CEP) of your country of education and if you have completed 9 out of 12 core subjects, in your course curriculum towards your degree, you are likely to qualify for a suitable skills assessment.

If you hold an accredited Australian Bachelor degree in accounting with CPAA, ICCA and NIA, and have completed 9 of 12 core subjects stated above, you will qualify for a suitable skills assessment without need of further study.

What happens if you are a member of an accounting professional body but do not satisfy the above qualifications pathway? If you are a current member of a professional body accredited by ICAA, it is likely that you will be issued with a suitable skills assessment for migration purposes by ICAA.

If the outcome of your skills assessment is suitable for migration purposes, you may submit it with your visa application without completing any further study. It is valid for 5 years.

But if your assessment is unsuccessful, the assessment letter will include details of study programs available in Australia, or by distance learning, to enable you to meet the required standard.
